TOWN OF GRAND ISLE SCHEDULED TOWN COUNCIL MEETING WEDNESDAY FEBRUARY 12, 2025 6:00 P.M.

The meeting was called to order by Mayor Pro Temp James Cheramie who led the Pledge of Allegiance to the American Flag. Leonard Ray followed with a prayer. Roll call was as follows:

Matthew Rivera with Rivere Entertainment was recognized: Request a beer and alcohol permit for concert being held at the Tarpon Rodeo Pavillion on May 24, 2025. Motion by Council Member Brian Barthelemy seconded by Council Member Michael Scioneaux and unanimously approved the town to issue permits. Point of Order was made by Council Member Brian Barthelemy noting that mayor pro-temp is not eligible to vote due to quorum.

Mike Keller was recognized: Asking about the beach crossovers what is the status to allow crossing onto the beach.

Request by Council Member James Cheramie to amend the minutes of January 8, 2025. Point of Order was called by Council Member Brian Barthelemy stating that a motion was needed to amend the agenda. Motion was made by Council Member Harley Stelly seconded by Council Member Michael Scioneaux to amend the agenda and accept the correction to January 8, 2025 minutes adding Point of Order made by Council Member James Cheramie raised last meeting where as anything added to agenda needs to be by a unanimous vote by council members. The Town Attorney received the Attorney General opinion and is in agreement.

The following proposed ordinance was introduced with the hearing schedule for the regular town meetings of January 8, 2025 and January 22, 2025 at which time it will be eligible for adoption.

ORDINANCE NO. 1045

An ordinance to approve the creation of Salty Vibes Camp Ground as an RV Park on a proposed six (6) space parcel of land located on a combined Tract 4-E-3/4 of Property belonging to Wayne Cheramie, on Cheramie Lane, Grand Isle, Jefferson Parish, Louisiana, in accordance with a plan prepared by Charles L. McDonald Land Surveyor, Inc., entitled, "MAP SHOWING SALTY VIBES CAMPGROUND BELONGING TO WAYNE CHERAMIE, LOCATED IN THE TOWN OF GRAND ISLE, JEFFERSON PARISH, LOUISIANA", dated 18 OCTOBER 2023.

WHEREAS, it is desired by owner, Wayne Cheramie, to create a 6 space RV park (Spaces 1 - 6) within Tract 4-E-3/4 of Property belonging to Wayne Cheramie (Cheramie Lane, Grand Isle, LA) creating an RV Park for the enjoyment and convenience for locals and visitors to be able to park an RV within the proposed park area for their camping and recreation needs; and

WHEREAS, it is desired by owner, Wayne Cheramie, to combine Tract 4-E-3 and Tract 4-E-4 into one combined Tract 4-E-3/4 of Property belonging to Wayne Cheramie in order to accommodate the creation of the RV Park identified as Salty Vibes Camp Ground; and

WHEREAS, owner, Wayne Cheramie (Salty Vibes Camp Ground) shall adhere and abide by all rules and regulations set forth by The Town of Grand Isle and Jefferson Parish as it relates to the creation and operation of the said proposed Salty Vibes Camp Ground;

NOW, THEREFORE, BE IT ORDAINED BY the Town Council of the Town of Grand Isle, Jefferson Parish, Louisiana that:

SECTION I: It is hereby declared, the approval to create an RV Park identified as Salty Vibes Camp Ground, all in accordance with a plan prepared by Charles L. McDonald Land Surveyor, Inc., entitled "MAP SHOWING SALTY VIBES CAMPGROUND BELONGING TO WAYNE CHERAMIE, LOCATED IN THE TOWN OF GRAND ISLE, JEFFERSON PARISH, LOUISIANA ", dated 18 OCTOBER 2023, for the enjoyment and convenience for locals and visitors to be able to park an RV within the proposed park area for their camping and recreation needs; and

SECTION II: It is hereby further declared, the approval of the proposed creation of Salty Vibes Camp Ground, that Wayne Cheramie, and any assigns to said Tract 4-E-3/4 of Property belonging to Wayne Cheramie, physical location being on Cheramie Lane, Grand Isle, Jefferson Parish, Louisiana. shall adhere and abide by all rules and regulations set forth by The Town of Grand Isle and Jefferson Parish as it relates to the creation and operation of RV Parks.

This ordinance was considered section by section and as a whole and was offered by Council Member Harley Stelly and seconded by Council Member Michael Scioneaux.

Assisting with LITACorp/Grand Isle DOT project. <u>Capital Outlay Request FY 2025-2026</u> – Road Rehabilitation, Central Island Drainage Project, Public Housing. <u>Orange Ln Pump</u> –Contractor has started the installation of steel sheet piles. <u>PPDR</u>– 28 total homes have been submitted. Working on bid documents. <u>Baseball Field</u> - Work is in progress for baseball & softball fields. Ronnie Sampey with the GIGC was recognized and reports on the following: 1.)
